NOTICE INVITING BID

Sealed bids affixing court fee stamp of Rs. 8.25 (Rupees Eight and Twenty Five Paisa) only are hereby invited from experienced catering firm/hotel and restaurant owners having sufficient manpower and managerial ability to supply food/cooked food items for providing Light Refreshment and Meal to the Officers and staff engaged in duties in connection with the conduct of **Assembly Elections 2026** with the terms & conditions as detailed below :

The bids shall be received in office chamber of Election Officer, Tinsukia up to **3:00 P.M. on 27/02/2026** and shall be opened on the same day at **4:00 P.M.** Tender Committee reserves all the rights to accept or reject any or all bids assigning any reason thereof.

Intending bidders may obtain the tender papers from Food, Public Distribution & Consumer Affairs Branch of the District Commissioner's Office, Tinsukia during office hours up-to **3:00 P.M. till 27.02.2026**

TERMS AND CONDITIONS

1. The intending bidders must have valid GST registration and submit GST return (GSTR-3B) of last 2 years.
2. The intending bidders must have valid FSSAI registration.
3. The intending bidders must have valid registration / license under local bodies.
4. The intending bidders must possess a valid Labour registration License.
5. The intending bidders shall have to furnish the copy of last 2 years ITR/Acknowledgement.
6. The Supplier must submit Undertaking on Statutory Tax Compliance as given as **Annexure – A**.
7. The intending bidders should have sufficient manpower to cater to the demand of 800-1200 persons at a time.
8. Priority will be given to the bidder having past experience of last 3 years in supplying Food & Refreshment during past elections in the State of Assam.
9. Care must be taken to pickup and destroy the waste products such as food waste, disposable cutleries, water bottles etc. from the dining hall & cooking shelter by the supplier himself.
10. Cleanliness should be maintained by the supplier concerned in an eco friendly manner.
11. Timely delivery & servicing of food items must be ensured by the supplier.
12. The nature / quantum of food items for supply shall be at the discretion of DC, Tinsukia. Further, issuance of supply order shall be only in the event of actual requirement as decided by this office and mere selection of the catering firm / hotel / restaurant through this short tender notice shall not entitle any right what so ever or placement of supply orders.
13. The D.C., Tinsukia reserves the right in all circumstances to accept or reject any tender without assigning any reason thereof, besides the rights of accepting tender of more than one supplier (provided the rates are found justifiable). In the event of any emergency and also based on the

demand of the situation or any other eventuality, the District Commissioner, Tinsukia reserves the right to procure food items from other sources.

14. The rates should be quoted inclusive of all taxes.
15. Bids submitted with unrealistic rates will be summarily rejected.
16. The supplier firm must have sufficient manpower and managerial ability to supply the food items against time to time on requisition to all persons engaged in election duties.
17. Transportation cost incurred in supply of food items shall have to be borne by the suppliers. No vehicle shall be provided for carrying food items from one place to another.
18. The suppliers shall have to arrange cookware and other cooking utensils at their own. No cost shall be borne by the District Administration in this connection.
19. All food items shall have to be served to the election related persons per day as per requirement fixed by the refreshment cell. The refreshment cell shall issue coupons/orders against all persons to whom refreshment shall be served and shall not be responsible for payment of any bills for serving unauthorized food to any persons without coupon / orders at any period of time.
20. All works related to supply of food items, cooking process and serving to election related personnel shall be done by the suppliers under strict supervision of Inspector / Sub-Inspector of Food, Public Distribution & Consumer Affairs or any other Officer / persons duly authorized by the i/c ADC, Food & Refreshment Cell. Authorized officers may give directions from time to time to ensure smooth distribution of food items to the personnel engaged in election duties maintaining quality of food and the supplier have to comply with such directions and non-compliances of directions resulting in untoward situation will lead to cancellation of contract at any point of time.
21. All food items (readymade or cooked) shall be tested by the Food Safety Officer or any other persons duly authorized by the District Commissioner, Tinsukia or competent authority before serving to any person engaged in election duty.
22. The supplier must be an experienced person/firm having minimum last 3 (three) years experience in dealing with supply of food items / cooked food and shall have to enclose a copy of experience certificate along with the bid.
23. All people to be engaged by the suppliers should obtain Identify Cards from the i/c Identity Cards Cell well ahead the scheduled date of election, for security reason, by providing proper ID & Address proof duly verified by the supplier.
24. All bills to be submitted by the suppliers must be accompanied either by supply order issued daily by the authorized officials of refreshment cell or by the certificates issued by the authorized officers of the refreshment cell.
25. The selected supplier/s shall have to sign a MOU with the District Commissioner or his representative prior to starting the work.
26. The suppliers must be a duly registered firm /contractor dealing with above items and should have labour registration / license as well GST registration. Pan card along with the attested copies of up-to-date Income Tax clearance certificate from the competent authority with the technical bid. Bidders without said documents shall be rejected.

27. The bidders shall have to deposit an earnest money (Refundable) in the form of demand draft worth Rs. 20,000.00 (Rupees twenty thousand) only payable to **TINSUKIA DEPUTY COMMISSIONER (ELECTION)** from any scheduled bank along with the bid.
28. The successful bidder/s shall have to deposit a sum of Rs. 2,50,000/- (Rupees Two Lakhs Fifty Thousand) only, in the form of Bank Draft from any Nationalized Bank pledged in favour of the **TINSUKIA DEPUTY COMMISSIONER (ELECTION)** as security money which shall be refundable on satisfactory completion of the assigned job.
29. If the suppliers fail to execute their responsibilities on time along with good quality of the job entrusted, the District Commissioner, Tinsukia reserves the right to reject the supplier and no compensation shall be paid for any service provided till such date since rejection of the supplier and the security money shall stand forfeited.
