MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING HELD ON 18/04/2023 AT THE CONFERENCE HALL OF COMMISSIONER'S OFFICE TINSUKIA

Members present- Enclosed at Annexure-1

The DDC meeting was presided over by Shri Swapneel Paul, IAS, Deputy Commissioner, Tinsukia. At the very outset of the meeting the Chairman & Deputy Commissioner welcomed all the Departmental Heads of the district.

The department wise discussions were as follows-

Agriculture:

- Regarding FPO formation, the Chair directed DAO to adopt a three pronged approach:
 - No FPO member should be deprived of other schemes of the department such as PM-KISAN, PMFBY in the district.
 - b) Conduct a study what are the processing unit proposal can be sent to govt. for approval
 - c) To start Innovative product i.e. One Block One Product programme in all the 7 blocks.
- The Chair instructed DAO to minimize the gap of Aadhar authenticated and e-KYC completed farmers in the district.

Agricultural Engineering :

> The Chair directed Ex. Eng. to conduct joint meeting with Deputy Commissioner, Agriculture department and Agricultural Engineering department after fixation of target for next financial year.

Food, Civil Supplies & CA:

- The Chair directed DDS, FCS&CA and DAO to achieve atleast 50 %(i.e.; atleast 4500 MT) target of paddy procurement before DCs Conference. In this regard, the Chair suggested DDS and DAO to push the farmers of the district and make them aware so that they don't have to resort to distress sell their produce to middlemen.
- > The Chair instructed DDS, FCS&CA for inclusion of new people under National Food Security Act (NFSA) in the district. In this regard the Chair stated that many eligible people in tea garden areas have not availed the benefit of NFSA due to Aadhar related issue and instructed DDS to bring more people of Tea garden areas under NFSA.

Labour welfare:

The Chair directed the Assistant Labour Commissioner Tinsukia to ensure that 100% Aadhaar ceeding in tea garden areas of the district is completed by 31st July this year.

DICC:

- The Chair directed the GM to bring detailed report of food processing unit of PMFME beneficiaries.
- The Chair directed the GM to conduct a review meeting related to all bank related schemes with District Development Commissioner as chairperson, Assistant Commissioners and HODs of concerned departments.

- Expressing satisfaction over progress of works of Amrit Sarovar, the Chair directed the BDOs to strive for achieving minimum 80% progress before DCs
- The Chair also instructed the BDOs to ensure 100% job card seeding of all the job card holders immediately.

DoHUA :

Deputy Commissioner stressed on maintaining quality of works on beautification of Na-Pukhuri and asked to provide deck, light and sound

system in Na-Pukhuri Park and also replace railings which are already

 Executive Engineer from DoHUA also informed the members regarding about ongoing process of automatic traffic signals in Tinsukia.

8. Irrigation:.

> Regarding achievement of Monitorable targets of DCs Conference by the Department, Ex. Engineer, Irrigation (Tinsukia/Digboi/Margherita division) appraised the Chair that 100% monitorable targets have been achieved under PMKSY-HKKP-GW-scheme in phase-II.

 Regarding OBOP scheme, the Chair directed the Ex. Engineer to provide irrigation facilities at all required places where OBOP initiatives have been

introduced.

9. Health:

 The Chair sought information from Jt. Director of Health Services regarding rationalization of 108 Ambulance in the district. In this regard the Jt. Director informed the Chair that a meeting will be held with the BDOs soon for rationalization of 108 Ambulance.

10. NULM:

 CPM, NULM informed the Chair that under Self Employment Programme 131% target have been achieved in providing individual loans.

> The Chair directed EO, Tinsukia Municipal Board to notify Town Vending

Committee under Street Vendors Act, 2014.

 EO, Tinsukia Municipal Board to conduct a survey of all permanent vendors in the town and regularize them subsequently under PM SVANidhi scheme.

11. Excise:

The superintendent of Excise informed the house that the revenue collection at the end of FY 2022-23 for Tinsukia district stands at 87.54%.

12. Transport:

On query regarding achievement of target for the FY 2022-23 by Transport Department, the DTO apprised the Chair that 92% target has been achieved by Tinsukia district in the last financial year.

The Chair instructed Ex. Engineer, PHE and DPM, ASDM to devise a Micro Plan for training of plumbers for Jal Jeevan Mission (JJM).

14. Education:

IS , Tinsukia informed that out of 23 Tea garden model schools,6 are yet to be inaugurated and made functional. He further stated that teacher for 6 schools have already been adjusted from other schools.

> IS Tinsukia also stated that no instructions has been received from Government for recruitment of clerical staffs in tea garden Model Schools.

Progress of AROHAN scheme was also reviewed and the Chair directed for registration of all IAS,ACS and ALRS officers as mentors and to approach probable mentors immediately and also to launch the scheme by conducting Mentor- Mentee programme immediately.

> On query regarding transfers of teachers the IS informed the Chair that in regards of mutual transfer, a DLC meeting will be held to finalize the names of teachers eligible for mutual transfer. In regards of Single transfer, SLC meeting will finalize the list of teachers who are eligible for single transfer.

15. T&CP:

- Ex. Engineer, T&CP apprised the Chair regarding 4 ongoing projects taken under CIDF in the department namely
 - a) Widening of Road with Drain from Railway station to Shivdham(Phase-I)
 - b) Widening of Road with Drain from Railway station to Shivdham(Phase-II)
 - c) Vegetable Market
 - d) Sunday Market

He further stated that Drainage Master Plan and GIS based Master Plan have already been approved by the government.

16. Water Resource:

- The Chair directed Asst. Ex. Eng, Water Resource to expedite the process of payment of compensation against land acquisition for World Bank aided Burhidehing Basin
- Project.

17. PWD(Building):

The Chair instructed the Ex. Engineer, PWD(Building) to submit the list of issues point wise relating to construction of the Medical College, Makum and also directed for ensuring completion of the works of Medical College prior to December this year.

18. PWD(NH):

- Regarding progress of works under the Department, the Ex. Engineer, PWD(NH) apprised the Chair that works of 4 projects are underway. They are namely
 - Ledo-Jairampur road (95% progress)
 - 2. PR of Tinsukia Bypass (95% Progress)
 - 3. Makum Digboi Road (40% Progress)
 - Illumination of Dhola Bridge over Brahmaputra River (10% progress)

19. Handloom & Textile :

- Regarding Enforcement drive against Powerloom made Gamosa and Mekhela Chador, the Superintendent of Handloom and Textile appraised the Chair that 800 pairs of powerloom made Mekhela Chador have been seized by the Department.
- On query regarding the success of Swanirbhar Naari scheme in the district, the Superintendent apprised the Chair that 10000 weavers have registered themselves under Swanirbhar Naari scheme in the district and Handloom made products have been procured from 200 weavers till date.
- The Chair instructed the Superintendent of H&T to conduct door to door survey to bring more weavers who are interested under the ambit of the scheme.

20. Soil Conservation:

Assistant Soil Conservation Officer appraised the Chair that projects of Natural Resource Management (NRM) works have already started and 75% progress has been achieved in this regard.

The Chair directed the Assistant Soil Conservation Officer to prepare water conservation plan and update the works under Jal Shakti Mission in Rastriya Jal Shakti Abhiyan portal regularly.

21. AH & Veterinary:

- The DVO informed the Chair that regular vaccination against Foot and Mouth Disease (FMD)/Brucellosis are going on in the district.
- On being enquired DVO, Tinsukia informed that 37 ASF infected pigs have been culled down in Kakopather to contain the spread of ASF.
- The Chair directed the DVO to focus on formation of FPOs for goatery farmers of the district.

The meeting ended with a vote of thanks from the chair.
