

MINUTES OF THE MEETING HELD ON 27/10/2021 ON MONITORABLE TARGETS FOR ASSESSMENT AT THE CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE TINSUKIA

Members present- Enclosed at **Annexure-1**

The DDC meeting was presided over by Shri Narsing Pawar, IAS, Deputy Commissioner, Tinsukia. At the very outset of the meeting the Chairman & Deputy Commissioner welcomed all the Departmental Heads of the district.

The departmental wise discussions on action points and monitorable targets for assessment were as follows:-

1. Food & Civil Supplies Department:

The Deputy Commissioner directed the Deputy Director of supply to strictly ensure the surrender of NFSA card by ineligible card holders. The Deputy Director apprised the house that 1796 nos of ineligible card holders has surrendered their cards till date. The Chair directed to ensure submission of undertaking by govt employees, failing which strict actions will be taken against the employees. The Deputy Commissioner also directed the Deputy Director that if any govt employee availing benefits under NFSA cards, then the fair price shop owners must inform the District Authority. The Chair also directed the Deputy Director to ensure adhar seeding in ration cards to enable One Nation, One Ration Card by 31/12/2021. The Deputy Director apprised the house that till now 54321 adhar seedings have been generated out of 7 lakhs Adhar Card holders. The Deputy Commissioner directed to complete the seeding before 31st December 2021. The Chair apprised that as much as adhar centres needed, it will be provided. At 'Raijor Adalot' also the adhar seeding and vaccination centres will be arranged for including maximum population within adhar and both the doses of covid vaccination.

2. PHE:

The Deputy Commissioner strictly directed the Ex. Eng PHE to speed up the works to meet up the targets of IHTC. The Chair directed that, the Ex. Eng must take initiative to speed up the works of retrofitting, as the progress of retrofitting is slow.

3. Transport:

The Deputy Commissioner directed the DTO for reducing the nos of road accidents by erecting signboards at accident prone areas, constructing speed breakers particularly to roads connecting to National Highways e. Apart from these, the DTO have to ensure the wearing of helmet and seat belt by applying the '**no helmet, no fuel**' policy to curb road accidents. The Chairman also directed to ensure medical fitness of all drivers and

handyman's. Priority should be given to the drivers and handyman's of school vehicles.

4. **Excise:**

The Chair directed the superintendent of excise to stop the circulation of illicit liquors from Arunachal Pradesh.

5. **Irrigation:**

The Ex. Eng Irrigation apprised the house that the Installation of 690 nos. Tube well Schemes under PMKSY-HKKP- access to ground water (Ph-II) under Tinsukia LAC, Digboi LAC, Margherita LAC, Doomdooma LAC & Sadiya LAC (175 nos. Solar TW and 515 nos. Electrical TW) under Tinsukia Division (Irrigation), Tinsukia For the year 2020-2021 is going on. The Ex. Eng apprised the house that by 30th Nov it will not be possible to complete the works . They will need extension of works for another two months.

6. **APDCL:**

The Deputy Commissioner asked the CEO to immediately complete replacement OF LED bulbs in govt schools. The Deputy Commissioner directed to ensure that LP schools, Anganwadi centres must be provided with LED bulbs. The CEO informed the house that at Amarpur, Sadiya solar is functional.

7. **Fishery:**

The DFDO apprised the house that they have received multipurpose applications and accordingly survey is going on. The Deputy Commissioner asked the DFDO to find out wetland potential areas and also to increase production of bigger fish. The DFDO apprised the house that Na- Pukhuri will be the convenient area for Signature Fisheries that is to be showcased as Tourist Destination,. The Deputy Commissioner directed all the Circle Officers that the khas lands with NOC should be allowed to converted into pond. The ponds should be of minimum one hectare if possible.

8. **Social Welfare:**

The Chairman directed the in charge District Social Welfare Officer to ensure the implementation of the scheme PM Matru Vandana Yojana . For construction of one stop centre The Deputy Commissioner directed the Circle Officer, Tinsukia to search one bigha of land.

9. **Housing and Urban Affairs :**

The Deputy Commissioner asked the Ex. Eng of PWD (B) to draw up a separate proposal for integrated DC Office. The Ex. Eng of PWD (B) informed the house that works of Kalayn Ashram has not been started yet.

10. Health:

The Deputy Commissioner directed the Joint Director of Health that maximum population is to be administered both the doses of covid vaccination at the 'Raijor Adalot' event. The Chair also informed the house that the remaining population will be vaccinated through Mobile Medical Unit and by home visit. Regarding anaemia, the Jt. Director of Health apprised the house that only 3% population of the total population of the district is suffering from acute anaemia. The Chairman also directed the Jt. Director health to create more awareness on proper diet and prescribe them with iron tablets. The Jt. Director also apprised the house that 96.4% pregnant women are giving birth through institutional delivery. The Deputy Commissioner asked the Jt. Director to ensure 100% institutional delivery. As IMR in the district are 10 and MMR is 85 which are higher than the state average. The Jt. Director informed the house that maximum death occurs in the garden areas. The Chairman directed the Jt. Director to find the root cause of death in the garden areas and accordingly create awareness by sensitizing ASHAs, ANM and other health workers so that the situations can be improved.

11. P& RD:

The Chairman directed all the BDO's to clear NOC issues from garden areas and rectify the landless beneficiaries' data by curtailing the ineligible beneficiaries under PMAY. The Chairman directed the Circle Officers to identify ceiling surplus lands so that those landless who are not getting NOC from garden authorities could be settled in such lands. Regarding MGNREGA, the BDO Guijan apprised the house that due to ongoing maintenance of SECURE app the updation is slow.

12. Education:

The Deputy Commissioner directed the representatives of DEEO & Inspector of Schools that amalgamation, Gunotsav III, and training on NISHTHA must be given more importance.

13. Agriculture:

The Deputy Commissioner directed the DAO to complete the distribution of remaining 6 tractors under CMSGUY. The Deputy Commissioner also asked the DAO to observe the probability whether good qualities maize can be produced in the district.

14. Revenue:

The ADC revenue apprised the house that NC village survey is going on and from 1st December focus will be given on disposal works under mission Basundhara.

15. Social Forestry:

The ADC forest apprised the house that in some eco sensitive zones of Guijan incidents of firing crackers are taking place which needs to be sort out soon . In this regard, the Deputy Commssioner directed the DFO, Tinsukia wildlife division to give a report to ADC, forest. The EX. Eng, PWD Tinsukia, Doomdooma and Sadiya territorial road division apprised the house that for 1.95 k.m roads they are not getting NOC even after diverting it from the core zone to eco sensitive zone. The Chair directed the EX. Eng to submit a detailed report on the matter.

The meeting ended with a vote of thanks from the Chair.
