**NOTIFICATION**

In pursuance of the Govt. Letter No. REGN.34/2021/18 dated 16<sup>th</sup> September'2021, Circle Officers had submitted proposed Zonal Value for various classes of land which were discussed in the DLLVC meeting held on 7<sup>th</sup> of February, 2022.

And that, the proposed Zonal value were published for inspection by general public in the Office of the Deputy Commissioner, Tinsukia, Office of the Sub-Divisional Officer (Civil), Margherita and Sadiya Sub-Division, Office of the Revenue Circle Tinsukia/ Doomdooma /Margherita Sadiya Revenue Circle, Gaon Panchayat Offices, Municipal Board Offices of Tinsukia/ Margherita/ Doomdooma/ Chapakhowa /Digboi /Makum within Tinsukia District. Claims and objections, in general were received in Tinsukia and Margherita Circle, which were addressed and sorted out by concerned Circle Officers. After making necessary rectification final draft of the Zonal Valuation was placed before the DLLVC Committee on 10<sup>th</sup> March, 2022 by respective Circle Officers along with justification for enhancement and was forwarded to Govt. for approval in due course of time.

The Revenue (Registration) and DM Department, Govt. of Assam has now approved the revised rates of Zonal Land Valuation of various classes of land for the year 2022-2024 for Tinsukia District vide letter REFN.87/2021/101, Dtd. 12<sup>th</sup> July, 2022 , which have been appended in the Circle wise list and the zonal values of different classes of land will be effective from **1<sup>st</sup> August, 2022 till 31<sup>st</sup> July, 2024** for the purpose of registration of immovable properties, land settlement, land reforms, land acquisition and for all other related matters.

The list of revised rates of Zonal Land Value will be available for inspection for various land related matters by public in the respective Office Sub-Divisional Offices (Civil), Margherita/Sadiya Sub-Division, Office of the Revenue Circle Tinsukia/ Doomdooma /Margherita. Sadiya Revenue Circle, Gaon Panchayat Offices/ Municipal Board Offices of Tinsukia/ Margherita/ Doomdooma/ Chapakhowa /Digboi /Makum and in the official website of Office of the Deputy Commissioner, Tinsukia i.e., <https://tinsukia.assam.gov.in>.

**This notification comes into effect from 1<sup>st</sup> August, 2022.**


