AUCTION NOTICE

Sealed bids/quotations affixing court fee stamp of Rs. 8.25 Rupees Eight and Twenty Five Paise) only are invited for disposal of various Government vehicles of various departments of Tinsukia District as described in "Annexure-A". The bids/quotations addressed to the Deputy Commissioner, Tinsukia in a sealed cover super scribed in capital letter with "OFFER FOR AUCTION SALE OF VEHICLES" along with earnest money of Rs. 1,000.00 (Rupees One Thousand) only in the shape of Bank Draft in favour of Deputy Commissioner, Tinsukia should be deposited latest by 15:00 hrs on 15.11.2022. The highest quoted price should be mentioned separately against each intended vehicle in «Annexure - A», without overwriting, and deposited along with the prescribed application proforma. A tender box will be kept for this purpose in front of the Nazarat Branch from 10:00 am to 3:00 pm on each working day till the last date. The bids/quotations received will be opened by the Tender Evaluation Committee on 15.11.2022 at 15:30 hrs in the conference hall of D.C.'s office, Tinsukia. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations. Before quoting bid, the vehicles may be inspected at the place where the same is lying as mentioned in Annexure-A during office hours on or before the last date of closure of tender.

The sale will be governed by the following terms and conditions:

1. Auction will be held on "AS IS WHERE IS" basis.
2. Each vehicle will be sold to the highest bidder of the respective vehicle. However, the undersigned reserves right to accept or reject any tender without assigning any reason thereof.
3. Quotation received without Bank Draft towards Earnest Money will not be accepted.
4. The bidder belonging to any of the schedule castes, schedule tribes or other backward classes will be required to deposit only 50% i.e. Rs. 500.00 (Rupees Five Hundred) as earnest money. Those who claim to belong to any of these categories must submit
 1. Caste Certificate from competent authority to establish the same.
5. The successful bidder will be required to deposit the complete bid amount by means of Bank Draft drawn in favour of the respective Head of Office within 7 (seven) working days of acceptance of the bid. Failing to do so will lead the bidder to forfeit the Earnest Money to the State Exchequer and the vehicle will be sold to the next highest bidder.

6. The earnest money deposited before start of auction shall be returned to the unsuccessful bidders.
7. Withdrawal of Bid once submitted is not permitted under any circumstances.
8. The Earnest money of the successful bidder will be released only after transfer of Vehicle Registration in his/her name.
9. The sold vehicle will be released only after the successful bidders submit their Identity and Address Proofs. In case of firm, registration certificate from competent authority may be submitted.
10. The successful bidders will have to remove the vehicle from the respective premises at his/her own cost within two days of issuance of sale certificate.
11. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his /her name at his /her own cost expeditiously and will be responsible for any misuse/accident related to the vehicle is used prior to transfer of registration. This office will not be responsible for any lapse on his part in this regard.
